Following documents in original and one set of self-attested photocopy are required for the admission process in this institute:

1. Admit card issued by NBE
2. Result/Rank letter issued by NBE
3. Marks sheets of BDS 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> professional examinations
4. B.D.S. Degree / Provisional Certificate
5. Internship completion certificate / Certificate from the head of Institution or college that the candidate shall complete the internship by 31<sup>st</sup> March, of the year of admission
6. Permanent / Provisional Registration Certificate issued by MCI or DCI / State Medical or Dental council. Provisional Registration Certificate is acceptable only in cases where candidate is undergoing internship and likely to complete the same on or before 31<sup>st</sup> March of the year of admission.
7. High School / Higher Secondary Certificate / Birth Certificate as proof of date of birth
8. Identification proofs (ID Proof) as mentioned in the information bulletin published by the National Board of Examinations (NBE) for AIPGMEE / AIPGDEE i.e PAN Card, Driving License, Voter ID, or Passport
9. Aadhar Card
10. The candidate should also bring the following certificates, if applicable
  - a. SC/ST Certificate issued by the competent authority (in the format as specified 7<sup>th</sup> page in the prospectus / Information Bulletin and should be in English or Hindi

language. Subcaste should be clearly mentioned in the certificate.

- b. OBC certificate issued by the competent authority. The sub-caste should tally with Central List of OBC. The OBC candidates should not belong to Creamy Layer. The OBC certificate must be in the format as mentioned in the prospectus / Information bulletin.
  - c. Disability certificate issued from a duly constituted and authorized Medical Board for 21 Benchmark Disabilities as per the Rights of Person with Disability Act, 2016. No other PwD certificate, issued by any other Authorities / Hospital will be entertained. The format of Certificate of Disability is attached as ANNEXURE – I of “Important questions related to scheme of PG Counseling 2020”.
